

# Candidates fail to hit deadline

## Harbor hopefuls can file late after they protest rule

In a small county race where candidates are unlikely to send out leaflets in the entire county, the race for seats on the San Mateo County Harbor District Commission can be won and lost with the inclusion of a ballot statement.

Which is why on Friday the county's Chief Elections Officer Mark Church emailed candidates, most of whom missed the deadline for filing their candidate statements, to inform them they could turn them in late.

He said it would ensure all voters are informed.

There are six contenders for four seats up for grabs on the harbor board. Three of the open seats are four-year posts while the other is a two-year post.

### Five of six candidates tardy

Candidates were required to file their statements when they filed their nomination papers on Aug. 12. But five of the six candidates failed to do that, Church said. Initially, only three of the

candidates who missed the deadline were able to submit their statements, after complaining about the rule. They included Tom Mattusch, Ed Larenas and Sabrina Brennan

Shawn Mooney, who is running for one of the four-year seats, requested to submit his statement only after hearing that those candidates were allowed to submit their statements late. In an email to the elections office, he complained that he was not informed about the exception.

"You learn that the county makes the rules up as they go along," said candidate Brian Rogers.

When Rogers, who is seeking a two-year post, received the Friday email from Church, Rogers called the elections office and asked to file his statement. After many phone calls, Rogers said, he was able to file Sunday.

### Leniency questioned

"Why do they get another crack at the ball? Neither of them submitted (their statements) last time," said commissioner Virginia Chang Kiraly, who was the only candidate to file on time. Kiraly is seeking a four-year seat.

The district collects about \$6 million in tax revenue and oversees Pillar Point in Half Moon Bay and Oyster Point in South San Francisco.
